Price quoted must be net, inclusive of all Government taxes and remain valid during the whole contract period.

Opening of the bids will take place at the Regional office in Meru immediately thereafter in presence of **only three (3) bidders** representatives who will be nominated by the other bidders.

Canvassing and/or any form of corrupt malpractice intended to influence the outcome of the whole or part of the process will lead to automatic disqualification irrespective of the procurement stage.

Information relating to the examination, evaluation and recommendation for successful candidates shall not be disclosed to applicants or other person not officially permitted until awards are communicated.
