- a) Valid NCA certificate for Road- works from National Construction Authority
- b) Certified Copies of certificate of registration, Certificate of Incorporation and principal place of business;
- c) Experience in works of a similar nature and size for each of the last five years, and clients who may be contacted for further information on these contracts;
- d) Major items of construction equipment owned;
- e) Qualifications and experience of key site management and technical personnel proposed for the Contract;
- f) Reports on the financial standing of the Tenderer, such as profit and loss statements and auditor's reports or bank statements for the last three months;
- g) Registration with National Construction Authority for the applicable class valid at the date of tender of submission
- h) Valid current Tax compliance certificate
- i) current litigation information
- j) Certified CR 12
